BYLAW No. 03-2019

A BYLAW TO AMEND BYLAW 2/2013 KNOWN AS THE ZONING BYLAW.


The Council of the Rural Municipality of Loon Lake No. 561 in the Province of Saskatchewan, enacts to amend Bylaw No. 2-2013 as follows:

1. The Zoning District Map which forms part of the Zoning Bylaw 2-2013 shall be rezoned as follows:

By rezoning from A – Agriculture District to C – Commercial/Industrial District, the property located in NE ¼ Sec 6 – Twp. 58 – Rge. 21 – W3Mer, as shown as within the bold dashed outlined area on the attached hereto and forms a part of this bylaw.

2. This bylaw shall come into force and take effect when approved by the Minister.



showing subdivision of part of

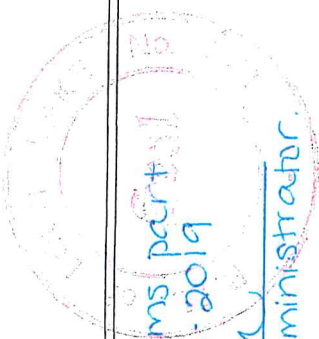
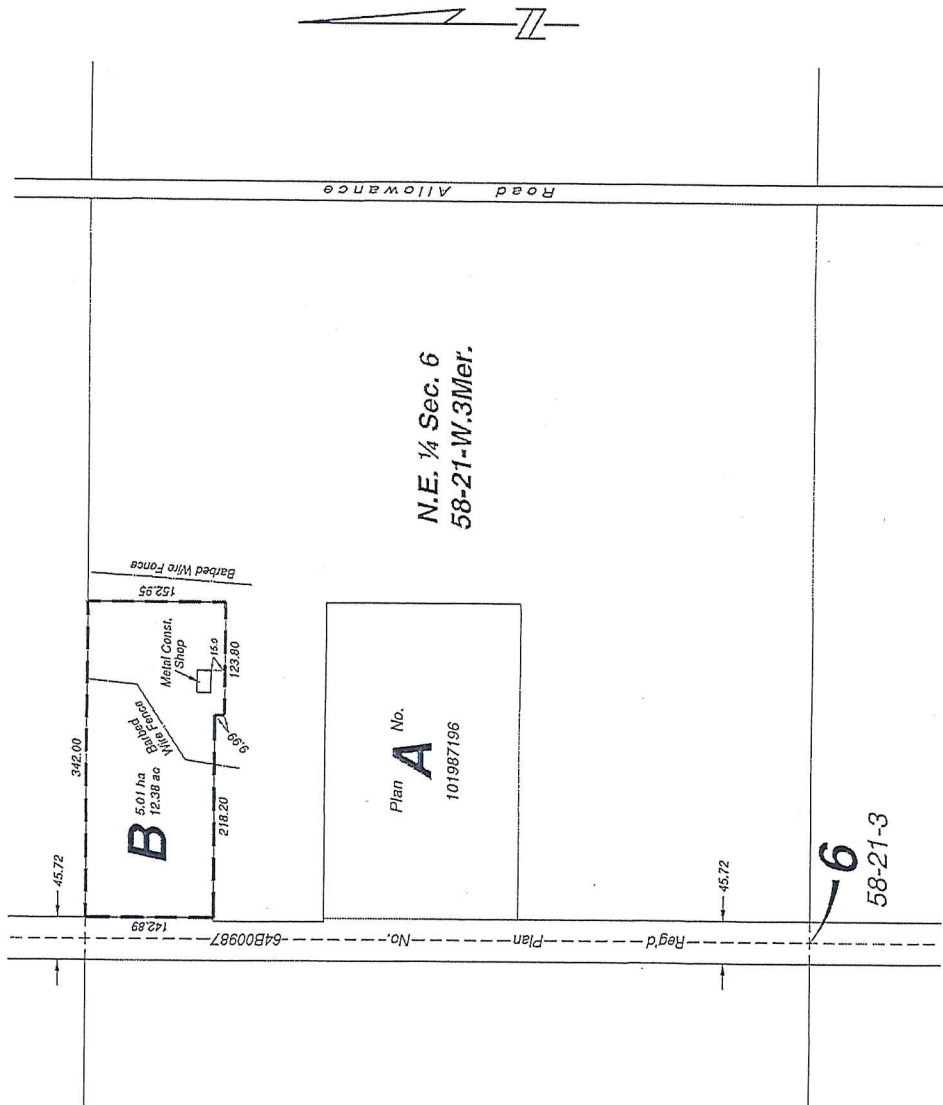
