## Hamlet Maintenance

Lori Scheidt shared that Ben Grassl and Nolan Wiebe will be assisting with the summer maintenance activities in the Hamlet this summer. The Hamlet has been unsuccessful recruiting a supervisor for the summer maintenance activities thus far and will accept applications from those who might be interested in that role.

Dust control for the Hamlet roads will be completed this month.

## Bridge:

The integrity of the bridge on Peck Lake Road will be assessed this summer as part of the provincial inspection program. An additional assessment will be completed by a contractor that is inspecting other bridges within the RM of Loon Lake. Reports from these assessments will be received in the fourth quarter of 2025 or early in 2026.

The Hamlet will continue to set aside reserve funds for the repair or replacement of this bridge.
