

Rural Municipality of Loon Lake No. 561

Bylaw No. 3-2017

A bylaw to amend Bylaw No. 2-2013 known as the Zoning Bylaw.

The Council for the RM of Loon Lake No. 561, in the Province of Saskatchewan, enacts to amend Bylaw No. 2-2013 as follows:

1. The Zoning District Map which forms part of the Zoning Bylaw 2-2013 shall be rezoned as follows:

By rezoning from LD1 – Low Density Lakeshore Development District to LD2 – Medium Density Lakeshore Development District, the property located in the NE 22-58-22-W3, Jumbo Beach Subdivision Lot 24 block 6 plan 78B17713 and lots 26 and 27, block 6 plan 102167018, as shown within the bold outlined area on the attached hereto and forms a part of this bylaw.

2. This bylaw shall come into force and take effect when approved by the Minister.

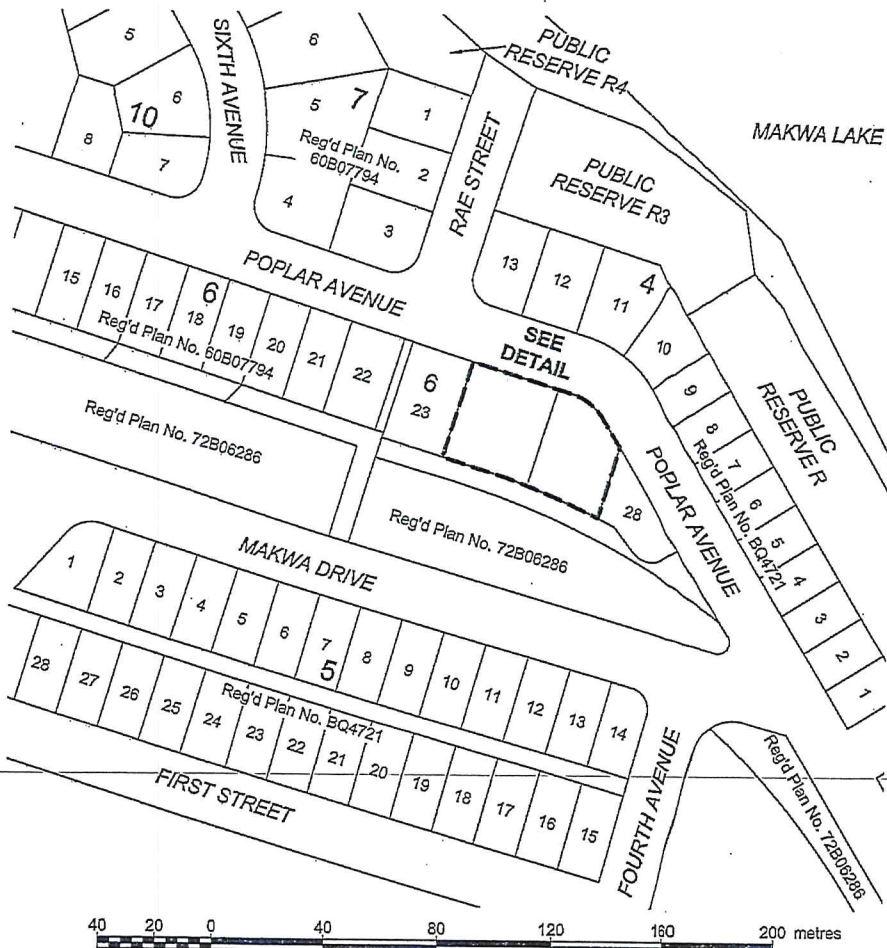
