A BYLAW TO AMEND BYLAW 2/2013 KNOWN AS THE ZONING BYLAW.


The Council of the Rural Municipality of Loon Lake No. 561 in the Province of Saskatchewan, enacts to amend Bylaw No. 2-2013 as follows:

1. The Zoning District Map which forms part of the Zoning Bylaw 2-2013 shall be rezoned as follows:

By rezoning from F – Provincial Forest to A – Agriculture District, the property located in SE ¼ Sec 19 – Twp. 58 – Rge. 24 – W3Mer. and NE ¼ Sec. 18 – Twp. 58 – Rge. 24 – W3Mer, as shown within the bold dashed outlined area on the attached hereto and forms a part of this bylaw.

2. This bylaw shall come into force and take effect when approved by the Minister.

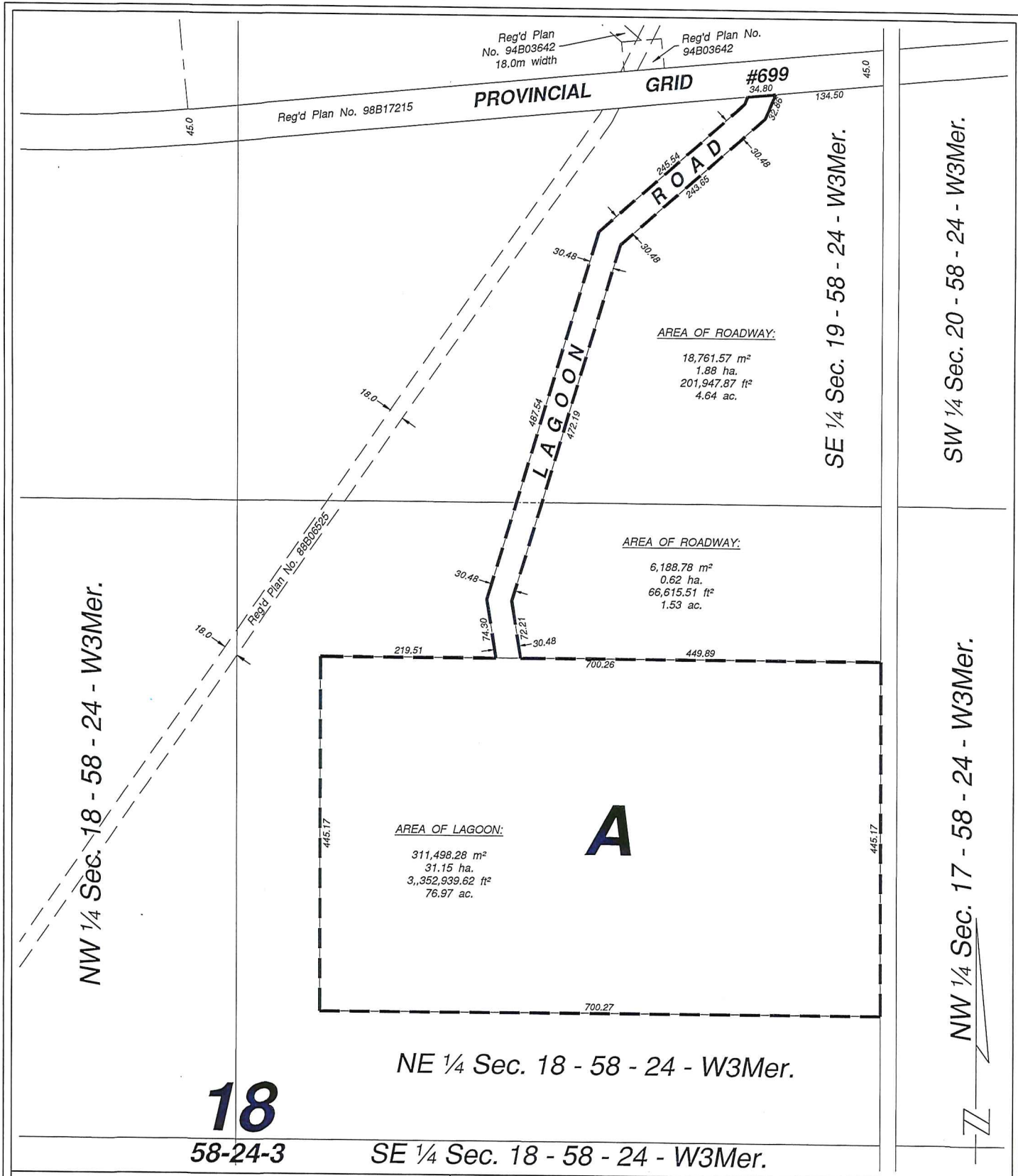
