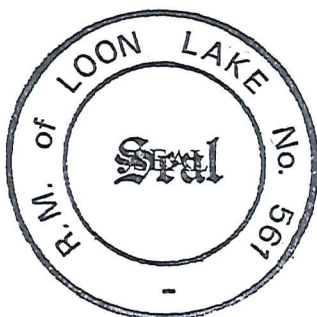
A BYLAW TO RECOVER PROTECTIVE SERVICES COSTS

The Council of the Rural Municipality of Loon Lake No. 561, in the Province of Saskatchewan, enacts as follows:

In this bylaw:

- a) "Administrator" shall mean the administrator of the municipality;
- b) "Council" shall mean the council of the municipality; and
- c) "Municipality" shall mean the Rural Municipality of Loon Lake No. 561

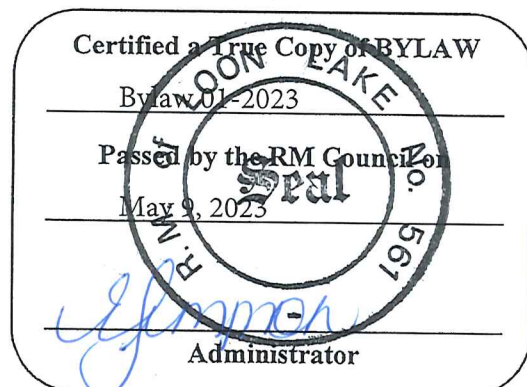
1. The cost of fire prevention, suppression and emergency response services shall be charged directly to the persons who receives the service in accordance with Schedule "A" which is attached to and forming a part of this bylaw.
2. The Council may authorize the Administrator to add to the taxes of any property owned by the person referenced in Section 2 of this bylaw any amount which remains unpaid at the end of the calendar year.
3. On all outstanding fire bills interest shall be applied at a rate of 1% per month after 90 days from the month end that the fire occurred.
4. This bylaw shall come into effect upon receiving third and final reading and shall repeal bylaw 05/2022.

**'Schedule A'**  
**Bylaw No. 01-2023**

**Set Rates for Billing Fire Costs**

That the RM of Loon Lake No. 561 (herein known as the RM) and the Village of Loon Lake (herein known as the Village) shall provide firefighting services to the incorporated areas of the RM and the Village on a fee – for – service basis.

On a fee for services basis and for the purpose of this bylaw the Village of Makwa shall be considered to be within the incorporated area of the RM of Loon Lake No. 561.

The fees charged for the firefighting services in the incorporated area shall be as follows:

1. \$450.00 per hour for Fire Truck (unit #2)
2. \$300.00 per hour for Tandem Tanker Water Truck (unit #3)
3. \$450.00 per hour for the Mini Pumper Truck (unit #1)
4. \$55.00 per hour for the Fire Chief
5. \$50.00 per hour for Fire Fighters
6. \$400.00 for Minimum Charge
7. \$100.00 per hour for use of personal vehicles during a fire authorized by the Fire Chief

The fees charged for firefighting services outside the incorporated area shall be as follows:

1. \$550.00 per hour for Fire Truck (unit #2)
2. \$400.00 per hour for Tandem Tanker Water Truck (unit #3)
3. \$550.00 per hour for the Mini Pumper Truck (unit #1)
4. \$60.00 per hour for the Fire Chief
5. \$55.00 per hour for Fire Fighters
6. \$500.00 for Minimum Charge
7. \$100.00 per hour for use of personal vehicles during a fire authorized by the Fire Chief

**False Calls**

- Land owners within the incorporated areas of the RM of Loon Lake shall receive a one-time per calendar year false call at a rate of \$550.00.
- Land owners within the incorporated areas of the Village of Loon Lake shall receive a one time per calendar year false call at a rate of \$100.00.
- The Loon Lake Fire Department Board shall be the deciding body on the determination of a false call.

**Additional Assistance**

All fees charged to the municipality for additional assistance for fire suppression supplied by another municipality, provincial government, fire department, contractor or any other persons or agencies shall be charged directly to person who received the service.
